## **RESOLUTION NO. 35 – 2024/2025**

RESOLUTION OF THE GOVERNING BOARD OF THE PERRIS ELEMENTARY SCHOOL DISTRICT REGARDING APPROVAL OF AN INTERIM MOBILE KITCHEN FACILITY AT SKY VIEW ELEMENTARY SCHOOL WITH EXEMPTION FROM DSA STRUCTURAL AND FIRE & LIFE SAFETY REVIEW, SUBJECT TO DSA ACCESS COMPLIANCE REVIEW

WHEREAS, the Perris Elementary School District ("District") operates Sky View Elementary School located at 625 Mildred Street; and

WHEREAS, the District has determined the need for an interim mobile kitchen facility to support food service operations at Sky View Elementary School due to the modernization of the existing kitchen; and

WHEREAS, the proposed interim mobile kitchen will consist of a modular or temporary facility to be installed on the school site and will be used exclusively for food preparation and service for the students and staff of Sky View Elementary School by food service personnel only. The interim mobile kitchen will be fenced off with a gate, lock, and signage, and have accessible staff restrooms nearby; and

WHEREAS, pursuant to Title 24 of the California Code of Regulations and Education Code Section 17280 et seq., school construction projects are generally subject to review and approval by the Division of the State Architect (DSA) for structural safety, fire and life safety, and access compliance; and

WHEREAS, Education Code Section 17293 and DSA Interpretation of Regulations (IR) A-22 allow certain interim or temporary facilities to be exempt from DSA review for structural and fire & life safety components, provided the District ensures compliance with applicable laws and retains responsibility for ensuring the adequacy and safety of the facility; and

WHEREAS, the District shall submit the interim mobile kitchen project to DSA for Access Compliance review and will ensure full compliance with the American Disabilities Act (ADA) and related accessibility standards; and

WHEREAS, the District affirms that the interim mobile kitchen will be installed and maintained in accordance with all applicable local, state, and federal regulations and will obtain all necessary approvals from the local fire authority, health department, and other applicable agencies.

**NOW, THEREFORE, BE IT RESOLVED** that the Governing Board of the Perris Elementary School District hereby approves the installation and use of the interim mobile kitchen facility at Sky View Elementary School and declares that:

1. The interim mobile kitchen facility is exempt from DSA Structural and Fire & Life Safety review under applicable provisions of California law and regulation.

- 2. The District shall submit the project to DSA for Access Compliance review and shall comply with all applicable accessibility standards.
- 3. The District shall ensure the facility is installed and maintained in accordance with all applicable safety, health, and code requirements.
- 4. The Superintendent or designee is authorized to take all actions necessary to implement this Resolution, including but not limited to contracting, permitting, and coordination with DSA and other relevant authorities.
- 5. This Resolution shall take effect immediately upon its adoption.
